## STATEMENT OF PER DIEM FEE AND CHARGES Effective January 1, 2024 (Revised April 1, 2025)

#### Per Diem:

\$1,650 per diem is applied to each day, or any part thereof, spent in hearings or study-opinion preparation. The per diem applies whether arbitrating or mediating.

#### **Expenses:**

<u>Chicago Metropolitan Area</u> (within 50 miles from Downtown Chicago): No charges in addition to per diem fee.

<u>Outside the Chicago Metropolitan Area</u>: Reasonable travel expenses included as incurred for transportation, meals, and lodging will be charged plus a flat half-day per diem for each day of travel.

**NOTE:** Between November 1 and March 31, hearings outside the Chicago Metropolitan Area are conducted via videoconference.

### **Cancellation:**

Notice of cancellations received less than 30 days before the scheduled hearing date(s) will be charged at the per diem rate. In addition, any transportation and/or hotel reservation cancellation fees incurred will be charged.

#### Invoices:

A detailed invoice of all charges will be submitted with the Opinion and Award. If the matter is settled or otherwise withdrawn from arbitration, an invoice will be sent for services reflecting charges and expenses incurred up to the point of notice of settlement or withdrawal from arbitration.
