**Minutes of the Local Panel Meeting**  
**Held on March 15, 2013**

**I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL**

**II. PRESENT**

Robert M. Gierut, Chairman; Charles E. Anderson, Member of the Board; Richard Lewis, Member of the Board; Melissa Mlynski, Executive Director (participated by telephone-conference); Jerald S. Post, General Counsel; and staff members.

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD February 7, 2013**

Chairman Gierut called for approval of the minutes of the February 7, 2013 meeting. Member Anderson moved to approve the minutes. Member Lewis seconded. The Board passed the motion unanimously, by a voice vote.

**IV. ADMINISTRATIVE MATTERS**

Chairman Gierut asked Executive Director Mlynski to present the Local Panel administrative actions report for the period of time from February 1 through February 28, 2013. She presented the report and summarized its highlights. The Board examined the report and discussed it.

**V. LEGISLATIVE/FISCAL REPORTS**

Executive Director Mlynski reported various legislative issues. She then presented the fiscal report, reviewing in detail the general ledger sheet and the disbursement record. The Board then discussed and questioned various aspects of the fiscal report.

**VI. BOARD ACTIONS**

**1. Case No. L-CA-10-076**

**International Brotherhood of Teamsters, Local 700/ County of Cook and Sheriff of Cook County**

Chairman Gierut called the case noting that no exceptions were filed for Administrative Law Judge Eileen Bell's Recommended Decision and Order (RDO) and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**2. Case No. L-CA-11-007**

**Amalgamated Transit Union, Local 241/ Chicago Transit Authority**

Chairman Gierut recused himself. General Counsel Post called the case noting that no exceptions were filed for ALJ Stevens' RDO and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**3. Case No. L-CA-12-022**

**Service Employees International Union, Local 73 / County of Cook**

Chairman Gierut called the case noting that no exceptions were filed for ALJ Hamburg-Gal's RDO and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**4. Case No. L-CB-13-009**

**Beverly Boyd/ American Federation of State, County and Municipal Employees, Council 31**

Chairman Gierut called the case. General Counsel Post then presented the case by stating that on December 19, 2012 the Executive Director dismissed the charge and an appeal had been filed. General Counsel Post stated that the Charging Party alleged that the Union engaged in unfair labor practices in violation of Section 10(b)(1) of the Illinois Public Labor Relations Act. General Counsel Post reviewed the issues raised by the Charging Party's appeal and then recommended that the Board affirm the Executive Director's dismissal. After discussion, Member Lewis moved to accept the dismissal. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**VII. EXECUTIVE SESSION**

After a short discussion regarding whether there was a need for executive session, the Board concluded that it was unnecessary at this time.

**VIII. ADJOURNMENT**

Chairman Gierut called for a motion to adjourn. Member Anderson made a motion to adjourn the meeting, and the Board passed it unanimously, by a voice vote.
