I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, Suite S-400, Chicago, IL

II. PRESENT

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD April 12, 2012

Chairman Gierut called for the approval of the minutes from the April 12, 2012 meeting. Member Sadlowski moved to approve the minutes of the April 12, 2012 meeting. Member Anderson seconded. The Board passed the motion unanimously, by a voice vote.

1. Case No. L-CA-12-010

Pamela Mercer/ County of Cook/Sheriff of Cook County

General Counsel Post reviewed the issues presented by Charging Party's appeal which alleges Respondent violated Section 10(a)(1) of the Act. Member Sadlowski seconded the motion, and the Board passed it unanimously, by a voice vote.

2. Case No. L-CB-12-006

Pamela Mercer/American Federation of State, County and Municipal Employees, Council 31

General Counsel Post reviewed the issues presented by Charging Party's appeal which alleges Respondent violated Section 10(b) of the Act.
