I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, S-401, Chicago, IL

II. PRESENT

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD August 13, 2019

Chairman Gierut called for approval of the minutes of the August 13, 2019 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a voice vote.

V. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS

**A. Case No. L-CA-18-072
Chicago Journeyman Plumbers' Local 130, U.A. and City of Chicago (Water Department)**

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

VI. BOARD ACTIONS

**1. Case No. L-CA-18-037
Policemen's Benevolent Labor Committee and County of Cook and Sheriff of Cook County**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Anderson moved to reject the Administrative Law Judge's Recommended Decision and Order. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.

**2. Case No. L-RC-19-006
American Federation of State, County and Municipal Employees, Council 31 and City of Chicago**

General Counsel Kim called the case, noted that Administrative Law Judge Anna Hamburg-Gal issued a Recommended Decision and Order with no exceptions filed and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**3. Case No. L-CA-19-095
Derek B. Webb and City of Chicago**

General Counsel Kim asked Associate General Counsel Hamburg-Gal to present the issues of the case to the Board. After discussion, Member Thomas moved to remand in part and affirm in part. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

VII. EXECUTIVE SESSION

After a short discussion regarding whether there was a need for executive session, the Board concluded it was unnecessary.

No members of the public sought to make comments.
