III. APPROVAL OF MINUTES OF REGULAR MEETING HELD February 6, 2018

**1. Case No. L-RC-14-004

**2. Case No. L-CB-18-002

VI. BOARD ACTIONS

**1. Case No. L-CA-16-017
Erek Slater/Chicago Transit Authority**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to accept the Administrative Law Judge's Recommended Decision and Order with modification. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**2. Case No. L-CA-16-023
Randle E. Martin/City of Chicago (Department of Streets and Sanitation)**

General Counsel Kim called the case, noted that no party filed exceptions to Administrative Law Judge Sharon Purcell's Recommended Decision and Order and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.
