I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, S-401, Chicago, IL

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD July 10, 2018

Chairman Gierut called for approval of the minutes of the July 10, 2018 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a voice vote.

V. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS

**1. Case No. L-CA-16-056
Annie Burton/Chicago Transit Authority**

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**2. Case No. L-CA-18-042
John J. Kugler/Chicago Park District**

General Counsel Kim called the case. Member Anderson made a motion to approve the proposed written decision. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.

VI. BOARD ACTIONS

**1. Case No. L-UC-17-002
American Federation of State, County and Municipal Employees, Council 31/City of Chicago**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to accept the Administrative Law Judge's Recommended Decision and Order. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**2. Case No. L-CA-16-016
Local 200, Chicago Joint Board, Retail Wholesale and Department Store Union/County of Cook, Health & Hospital System**

General Counsel Kim called the case and noted that no party filed exceptions to Executive Director, Acting Administrative Law Judge Kimberly F. Stevens's Recommended Decision and Order and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**3. Case No. L-CA-18-006
Brian C. Johnson/Chicago Transit Authority**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Anderson moved to accept the Executive Director dismissal. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.

**4. Case No. L-CA-18-018
National Nurses Organizing Committee/County of Cook, Health & Hospital System**

General Counsel Kim asked Associate General Counsel Anna Hamburg-Gal to call and present the issues of the case to the Board. After discussion, Member Anderson moved to accept the Executive Director dismissal. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.

**5. Case No. L-CA-14-066
Amalgamated Transit Union, Local 308/Chicago Transit Authority**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to defer under Spielberg doctrine and dismiss the complaint for hearing. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**6. Case No. L-CB-06-035-C
Carmelthia Otis, Delcina Rosado, Christiana Ohear-Enyeazu, Marshall Berry, Gabriel Nwandu, Britten McBride, Ashok Gandhi, Lindon Hampton, Dhirajlal Jagatia, Synthia Miller, Boniface Nwanesi, & Hayan Rgval/Chicago Joint Board, Local 200, Retail, Wholesale and Department Store Union**

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Anderson moved to appoint the General Counsel to conduct proceedings in accordance with the court's order. Member Thomas seconded the motion, and the Board passed it unanimously, by a voice vote.
