III. APPROVAL OF MINUTES OF REGULAR MEETING HELD April 9, 2019

V. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS

A. Case No. L-CA-18-041

Illinois Fraternal Order of Police and County of Cook and Sheriff of Cook County

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

B. Case No. L-CB-19-013

Fahad Nazir and Cook County Pharmacy Assoc., Chicago Joint Board, Retail, Wholesale and Department Store Union, Local 200

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

C. <u>Case No. L-CB-19-014</u>

Fahad Nazir and Cook County Pharmacy Assoc., Chicago Joint Board, Retail, Wholesale and Department Store Union, Local 200

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

VI. BOARD ACTIONS

1. <u>Case No. L-CA-16-049</u>

Anthony Vose and County of Cook and Sheriff of Cook County

General Counsel Kim called the case, noted that Administrative Law Judge Anna Hamburg-Gal issued a Recommended Decision and Order with no exceptions filed and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

2. <u>Case No. L-CA-18-061</u> Tony L. Carodine, et al. and Chicago Transit Authority

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to grant variance to consider the charging party's appeal. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote. Member Thomas then moved to accept the Executive Director's dismissal. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

3. <u>Case No. L-CB-18-031</u> Luis G. Diaz, et al. and Amalgamated Transit Union, Locals 241 and 308

General Counsel Kim called and presented the issues of the case to the Board. After lengthy discussion, Member Thomas moved to grant variance to consider charging party's appeal. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote. Member Thomas then moved to remand cases L-CB-18-004 and L-CB-18-040 for further investigation and to accept the Executive Director's dismissal on the other Luis Diaz et al. cases. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.
