I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, S-401, Chicago, IL

III. APPROVAL OF MINUTES OF REGULAR MEETING HELD May 7, 2019

Chairman Gierut called for approval of the minutes of the May 7, 2019 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a voice vote.

Chairman Gierut asked Executive Director Stevens to present the reports. She presented the reports and summarized their highlights.

V. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS

A. Case No. L-CA-18-061

Tony L. Carodine, *et al.*, and Chicago Transit Authority

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

B. Case No. L-CB-18-031

Luis G. Diaz, *et al.*, and Amalgamated Transit Union, Locals 241 and 308

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

VI. BOARD ACTIONS

1. Case No. L-RC-16-035

American Federation of State, County and Municipal Employees, Council 31 and City of Chicago

General Counsel Kim called and presented the issues of the case to the Board. After discussion, Member Thomas moved to accept the Administrative Law Judge's Recommended Decision and Order. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

2. Case No. L-UC-18-006

American Federation of State, County and Municipal Employees, Council 31 and City of Chicago

General Counsel Kim called the case, noted that Administrative Law Judge Anna Hamburg-Gal issued a Recommended Decision and Order with no exceptions filed and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**3. Case No. L-CB-19-020
Glen Jones and Amalgamated Transit Union, Local 241**

Associate General Counsel Hamburg-Gal called and presented the issues of the case to the Board. After lengthy discussion, Member Thomas moved to accept the Executive Director's dismissal with modifications. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**4. Case No. L-CA-16-079
City of Chicago and Fraternal Order of Police**

General Counsel Kim stated that the parties filed a joint request for the Board to continue to hold this case in abeyance. After discussion, Member Thomas moved to grant the request to continue to hold this case in abeyance. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.

**5. Case No. L-CA-17-034
City of Chicago and Fraternal Order of Police**

General Counsel Kim stated that the parties filed a joint request for the Board to continue to hold this case in abeyance. After discussion, Member Thomas moved to grant the request to continue to hold this case in abeyance. Member Anderson seconded the motion, and the Board passed it unanimously, by a voice vote.
