**Minutes of the Local Panel Meeting  
Held on December 10, 2020**

**I. OPENING OF MEETING 10:00 A.M.—160 North LaSalle Street, S-401, Chicago, IL**

**II. PRESENT**

**III. APPROVAL OF MINUTES OF REGULAR MEETING HELD November 19, 2020**

Chairman Gierut called for approval of the minutes of the November 19, 2020 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a roll call and voice vote.

**A. Case No. L-CB-20-021**

Tommy Sams, Jr. and Amalgamated Transit Union, Local 241

General Counsel Kim called the case. Member Anderson made a motion to approve the proposed written decision. Member Thomas seconded the motion, and the Board passed it unanimously, by a roll call and voice vote.

**B. Case No. L-CA-20-018**

Teamsters Local 700 and County of Cook and Cook County Sheriffs

General Counsel Kim called the case. Member Thomas made a motion to approve the proposed written decision. Member Anderson seconded the motion, and the Board passed it unanimously, by a roll call and voice vote.

**VI. BOARD ACTIONS**

**1. Case No. L-RC-19-015**

**American Federation of State, County and Municipal Employees, Council 31 and City of Chicago**

General Counsel Kim called the case, noted that no party filed exceptions to Administrative Law Judge Owen's Recommended Decision and Order and asked whether the Board wished to review the decision on its own motion. The Board declined to do so.

**2. Case No. L-CB-19-047  
Frank Donis and International Brotherhood of Teamsters, Local 700**

General Counsel Kim called and presented the case. After discussion, Member Anderson made a motion to remand for further investigation of the Executive Director Dismissal. Member Thomas seconded the motion, and the Board passed it unanimously, by a roll call and voice vote.
