III. APPROVAL OF MINUTES OF REGULAR MEETING HELD March 11, 2021

Chairman Sered called for approval of the minutes of the March 11, 2021 meeting. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a roll call and voice vote.

- A. Case No. L-RC-21-006
Front Line Labor Alliance and County of Cook and Cook County Sheriff and International Brotherhood of Teamsters Local 700**
