III. APPROVAL OF MINUTES OF REGULAR MEETING HELD on September 23, 2021.

Chairman Sered called for approval of the minutes of the regular meeting held September 23, 2021. Member Anderson moved to approve the minutes. Member Thomas seconded. The Board passed the motion unanimously, by a voice vote.

V. REVIEW OF PROPOSED WRITTEN DECISIONS AND ORDERS

**A. Case No. L-RC-19-024
AFSCME, Council 31 and City of Chicago**

**A. Case No. L-CA-20-019
Fraternal Order of Police, Lodge 7 and City of Chicago (Department of Police)**

**B. Case No. L-RC-21-012

**C. Case No. L*CB-21-003
Kierra Cox and ATU, Local 241**

Member Thomas made a motion to strike the appeal and affirm the dismissal. Member Anderson seconded the motion, and the Board passed it unanimously, by a roll call and voice vote.

**D. Case No. L-CA-16-079
City of Chicago and Fraternal Order of Police**

General Counsel Kim called and presented the case. Chairman Sered called for a motion to continue to hold the case in abeyance. Member Anderson made a motion to continue to hold the case in abeyance. Member Thomas seconded the motion, and the Board passed it unanimously, by a roll call and voice vote.

**E. Case No. L-CA-17-034
City of Chicago and Fraternal Order of Police**

Member Thomas seconded the motion, and the Board passed it unanimously, by a roll call and voice vote.
